- **W-9 & Direct Deposit:**
 - Drivers or owners (whoever wishes to receive payment) must complete the attached W-9 and Direct Deposit form.
- **Car Number Registration:**
 - Only owners can register a car number. All owners must fill out a W-9 to receive any track winnings.
- **Payment Details:**
 - Track winnings will be paid via Direct Deposit by the Wednesday following a race. If the owner prefers a check, it can be picked up at the Pit Booth on the next race day (checks will no longer be mailed).
- **NASCAR Licenses:**
 - Owners and crew members can apply for NASCAR Licenses. All drivers must be licensed. Licensed individuals receive discounted pit pass rates.
- **Driver/Team Information Sheets:**

- Drivers must fill out the Driver/Team Information sheets attached to this form.

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration of being permitted to enter for any purpose, any restricted area (herein defined as including but not limited to the race surface, pit areas, infield, burnout area, tunnel area, approach area, shut down area, and all walkways, concessions, and other areas appurtenant to any area where any activity related to the event shall take place), or being complete, officiate, observe, work for, or for any reason participate in any way in the event. Each of the undersigned, for himself, his/her personal representatives, heirs, and next of kin, acknowledges, agrees, and represents that he/she has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which he/she enters and with which he/she comes in contact, and he/she does further warrant that his/her entry upon such restricted area or areas and his/her participation, if any, in the event constitutes an acknowledgment that he/she has inspected such restricted area and that he/she finds and accepts the same as being safe and reasonably suited for the purposes of his/her use, and further agrees and warrants that if, at any time, he/she is in or about restricted areas and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and will leave the restricted areas:

1. **HEREBY RELEASES, WAIVERS, DISCHARGES AND COVENANTS NOT TO SUE:** the Promoters, Participants, Racing Association, Sanctioning Organization or any subdivision thereof, Track Operator, Track Owner, Officials, Car Owners, Drivers, Pit Crews, any persons in any restricted area, Promoters, Sponsors, Advertisers, Owners and Leasees of premises used to conduct the event and each of them, their officers, and employees, all for the purposes herein referred to as "Releasee" from all liability to the undersigned, his/her personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands thereof on account of injury to the person or property or resulting in death of the undersigned, whether caused by negligence of the releasee or otherwise while the undersigned is in or upon the restricted area, and/or competing, officiating in, observing, working for, or for any purpose participating in the event.
2. **HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS:** The releasee and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by negligence of the releasee or otherwise.
3. **HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE:** Due to the negligence of releasee or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.
4. **EACH OF THE UNDERSIGNED:** Expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. Each of the undersigned further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall notwithstanding, continue in full legal force and effect.
5. **ADVERTISING RELEASE:** The undersigned consents to the use of his/her and/or pictures of his/her self, and/or car, for publicity, advertising and endorsements, both before and after events, and relinquishes any rights to photos taken in connection with events, and consents to the publication or sale of such photos by the speedway.
6. **ARBITRATION:** Any dispute, controversy or claim involving the undersigned member, whether or not relating to this agreement or alleged breach of same, shall be settled in accordance with the existing and/or amended rules and regulations of the speedway, and the undersigned agrees to accept the decisions rendered by such process.
7. **CONSIDERATION AND COMPLIANCE:** In consideration of acceptance by the Seekonk Speedway of this application and payment of the license fees the undersigned agrees to abide by all rules and regulations of the Seekonk Speedway as to conduct and follow mechanical specifications, as now published, or hereafter modified. Undersigned further recognizes his/her obligation to the public and the Seekonk Speedway, which posts the prize monies and conducts the events, and agrees to compete in all events for which he/she may be qualified, if humanly possible.

Any car owner/.driver by competing in any race at Seekonk Speedway specifically agrees and acknowledges the following: That he/she understands that it is illegal to soak or treat tires and that said soaking or treatment of racing tires is against EPA Regulations and further contains carcinogens and hazardous materials, that are unfit for his/her health and the health of all competitors, Seekonk Speedway Personnel and Spectators. As car owner/.driver I agree that I will bear the total responsibility for any claims arising from the use of tire softeners, tire enhancers, or tire treatments, and I will indemnify and hold Seekonk Speedway harmless against any claim arising from the use of tire soaking, tire enhancing, or tire treatment.

The undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement, and further agrees that no oral

representations, statements, or inducements apart from the forgoing written agreement have been made.
